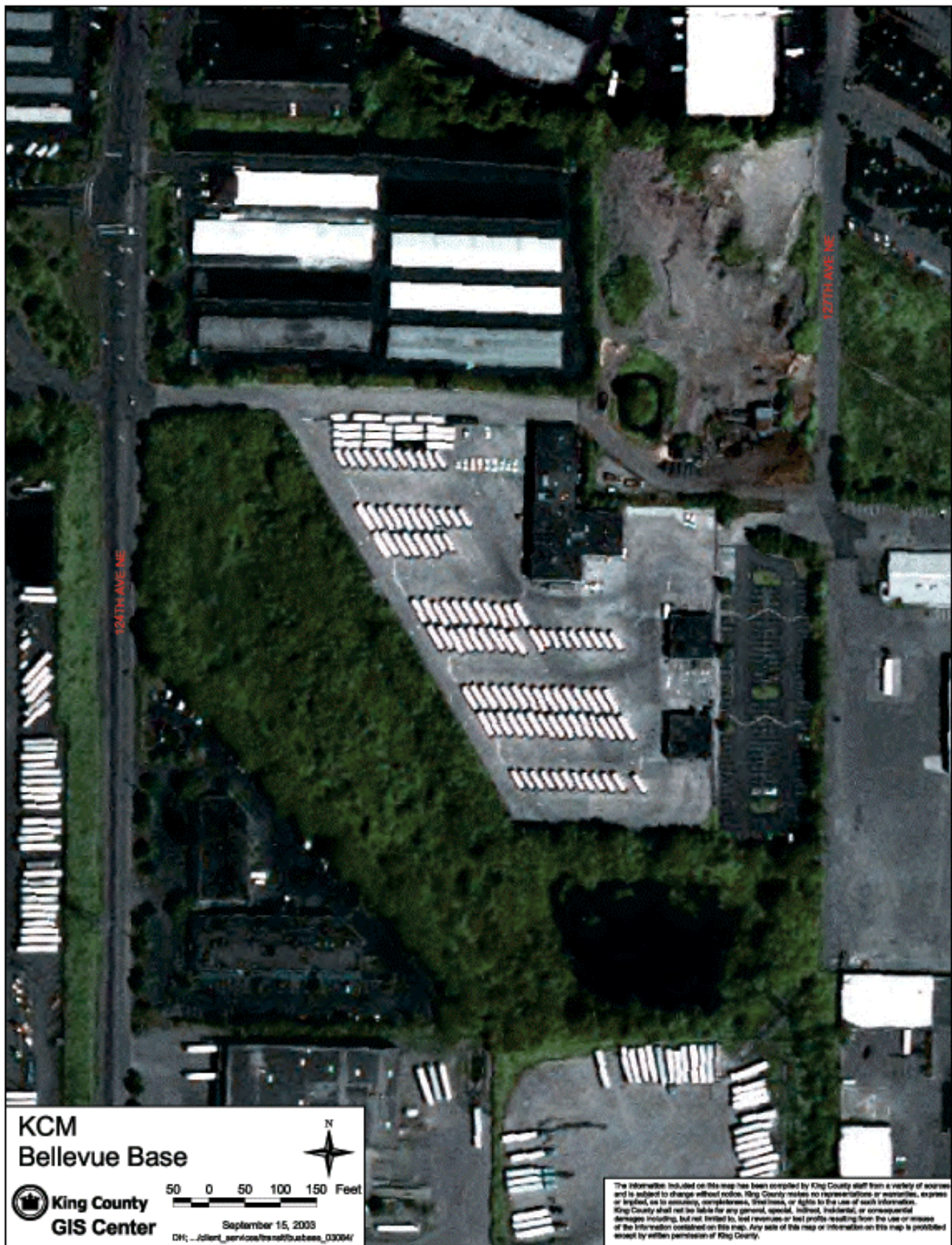

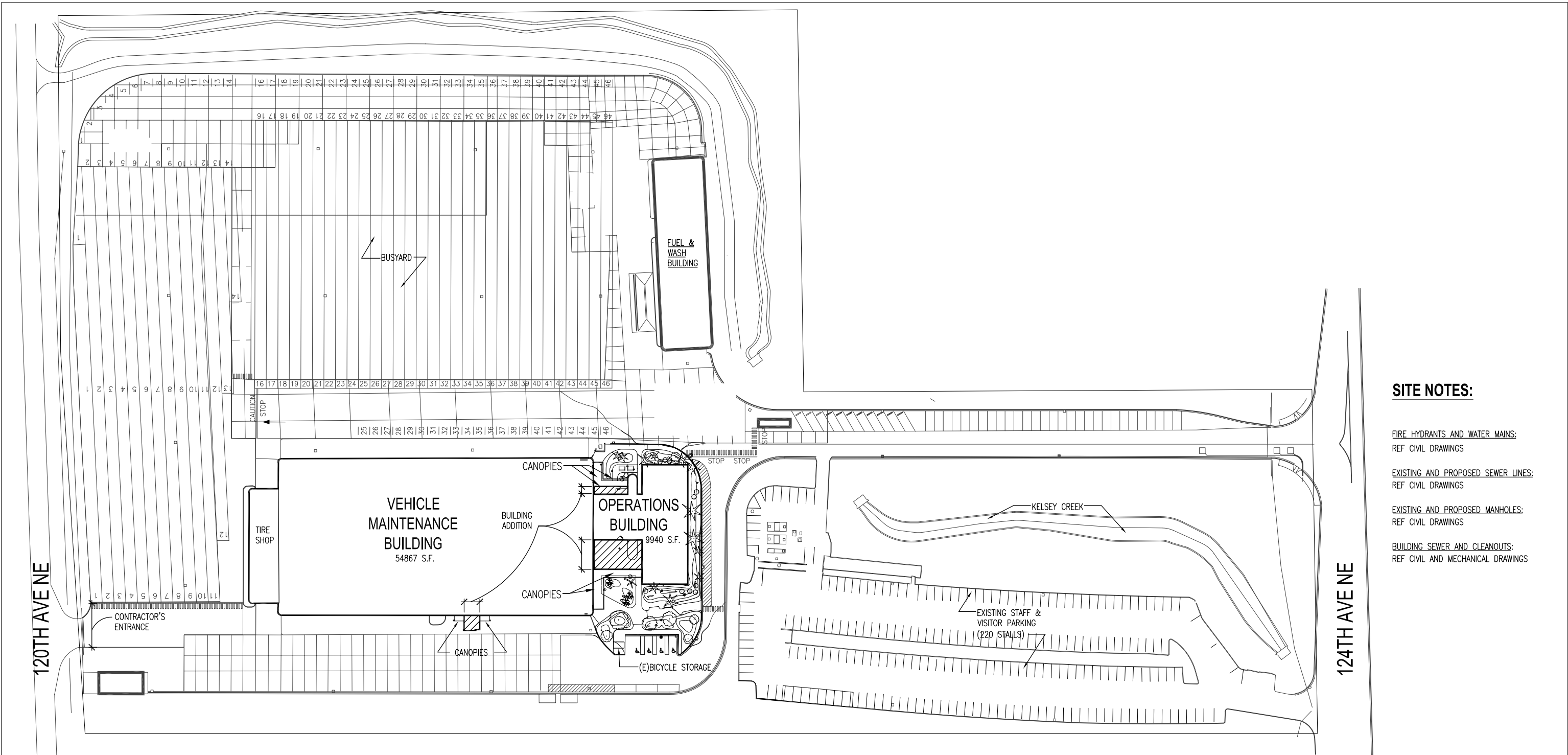

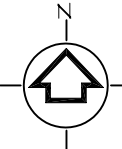
THAT PORTION OF THE NORTHWEST QUARTER OF SECTION 28, TOWNSHIP 25 NORTH, RANGE 5 EAST, W. M., IN KING COUNTY, WASHINGTON, DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF SAID SUBDIVISION; THENCE NORTH 0°42'15" EAST ALONG THE EAST LINE THEREOF 761.50 FEET TO THE TRUE POINT OF BEGINNING; THENCE NORTH 89°21'05" WEST PARALLEL WITH THE SOUTH LINE OF SAID SUBDIVISION 1286.31 FEET TO THE EAST MARGIN OF 120TH AVENUE NORTHEAST; THENCE NORTH 2° 01'39" WEST ALONG SAID MARGIN 389.63 FEET; THENCE NORTH 1°12'00" EAST ALONG SAID MARGIN 342.42 FEET TO A LINE WHICH IS PERPENDICULAR TO THE WEST LINE OF SAID SUBDIVISION AND PASSES THROUGH A POINT NORTH 88°21'06" WEST 1338.50 FEET AND

NORTH 1°11'41" EAST (PARALLEL WITH SAID WEST LINE) 731 FEET FROM THE TRUE POINT OF BEGINNING; THENCE SOUTH 88°48'14" EAST ALONG SAID PERPENDICULAR LINE 753.32 FEET TO THE WEST LINE OF THE EAST 548 FEET OF SAID SUBDIVISION AS MEASURED ALONG THE NORTH LINE THEREOF; THENCE SOUTH 0°42'15" WEST ALONG SAID WEST LINE 389.36 FEET TO THE SOUTH LINE OF THE NORTH 1511.02 FEET OF SAID SUBDIVISION AS MEASURED ALONG THE EAST LINE THEREOF; THENCE SOUTH 88°37'39" EAST ALONG SAID SOUTH LINE 548.00 FEET TO SAID WEST LINE OF SAID SUBDIVISION; THENCE SOUTH 0° 42'15" WEST ALONG SAID WEST LINE 350.23 FEET TO THE TRUE POINT OF BEGINNING. 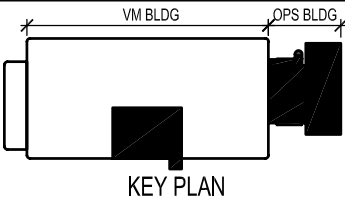

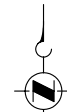
